PETITION

(Brought Under Articles 2, 3, 21, 119, 137 (3) & (4) and 154 of the Constitution of the Republic of Uganda and Constitutional Court (Petitions and References) Rules, SI 91/2005)

THE HUMBLE PETITION OF GAWAYA TEGULLE, Esq. whose address for the purpose of this petition is stated at the foot of this petition, states-

- 1. THAT Your Petitioner is a male adult Ugandan of sound mind, a member of the Uganda Law Society, a practicing Advocate of Uganda's Courts of Judicature, and also a Human Rights, Democracy, Constitutionalism and Good governance Activist. He is especially keen on constitutionalism and believes that as a good citizen, he has a duty to safeguard, ensure and generally protect the sanctity of the Constitution of the Republic of Uganda.

2. **THAT** the 1st Respondent is a Ugandan Citizen of sound mind and a serving army officer with the Uganda People's Defence Forces (UPDF) at the rank of Lieutenant General where he is the Commander of the Land Forces and he is being sued in that capacity.
3. **THAT** the 2nd Respondent is the Chief of Defence Forces (CDF) of Uganda, and has a duty to oversee the military arm of the government and run the affairs of the said military in a manner unswervingly and unfailingly consistent with and as envisaged by the Constitution of the Republic of Uganda.
4. **THAT** the 3rd Respondent is the Principal Legal Advisor to the government of the Republic of Uganda and is Constitutionally mandated by **Article 119** of the Constitution to give legal advice and offer legal services to the government, and further, to represent the government in Court and has been sued in that capacity.
5. **THAT** the Petitioner herein is an ardent believer in the rule of law, Constitutional Governance, Fundamental Human Rights and Freedoms and good governance and brings this petition in the higher public interest, to seek the interpretation of the matters herein which he firmly believes have created an abyss for the abuse of the sanctity of the Constitution as follows hereunder:

- a) The acts of the 1st Respondent dubbed as “MK@48” including national and district “birthday celebrations” as well as the political pronouncements in general and the manifest presidential campaigns in particular, on the 1st Respondent’s twitter handle “@MK” are inconsistent with and a contravention of Article 208 (2) of the Constitution of the Republic of Uganda which provides that “The Uganda People’s Defence Forces (UPDF) shall be non-partisan, national in character, patriotic, professional, disciplined, productive and subordinate to the civilian authority as established under this Constitution” and also in violation of Articles 2, 3, 209 and 210.
- b) The failure or omission of the 2nd Respondent to advise or warn the 1st Respondent about the legality and untenable nature of his actions, character and conduct even when it can clearly be seen that they are in contravention of the Constitution of the Republic of Uganda and the Uganda People’s Defence Forces (UPDF) Act, or restrain his clearly highhanded and manifestly unlawful actions, amount to failure to provide due leadership, guidance, oversight and command expected of a conscientious and competent Chief of Defence Forces, and thereby offends Articles 2 and 208 (2) of the Constitution.
- c) The 3rd Respondent has omitted, failed or otherwise refused to provide good, fitting and proper legal advice and guidance to the UPDF in general and the 1st Respondent in particular that the acts and overtures of the 1st Respondent are manifestly unconstitutional and not tenable in an army which is supposed to

be professional, non-partisan and of good character, thereby offending Articles 2 and 119 (4) (a) of the Constitution.

- d) The above acts of the 1st Respondent in as far as they infringe and violate the Constitution are inconsistent with and a contravention of Article 3 of the Constitution rendering him liable for punishment in accordance with the law.
- e) The act of the 1st Respondent and security infrastructure in Uganda comprising of the Uganda Peoples Defence Forces (UPDF), Uganda Police Force (UPF) and other security agencies in charging part of the expenditure of the birthday party and other attendant activities on the Consolidated Fund is contrary to Articles 2 and 154 of the Constitution.
- f) The 1st Respondent, who also happens to be the son of the current President of the Republic of Uganda, General Yoweri Kaguta Tibuhaburwa Museveni, is enjoying unlawful and unconstitutional preferential treatment from the UPDF, and is not being duly reprimanded, supervised or otherwise called to order by the 2nd Respondent simply because he is the son of the President, which manifestly offends **Article 21** that provides for equality before and under the law.

6. **THAT** your Petitioner is aggrieved by the acts of the 1st Respondent for contravening and being inconsistent to the Constitution on the following grounds:

- (i) The acts of the 1st Respondent being a serving officer of the UPDF are political and partisan in nature aimed at promoting the Chwezi dynasty through the succession of the incumbent president and father to the 1st Respondent.
- (ii) The acts of the 1st Respondent being a serving officer of the UPDF are political and partisan in nature aimed at promoting the National Resistance Movement (NRM) Party headed by his father.
- (iii) The activities of MK@48 and the Twitter handle of the 1st Respondent are political in nature aimed at taking over power as successor to his father using methods and means not consistent with the Grundnorm.
- (iv) The inaction or loud silence equivalent to the approval or sanction by the UPDF establishment of the activities of the 1st Respondent who is both a serving officer and son of the CIC.
- (v) Previously, acts with political overtones by serving officers – take Gen. David Tinyefuza (now Sejusa) and Maj. Gen. Henry Tumukunde have been met with quick, malevolent crackdowns by the UPDF, which included suspensions and court proceedings in the name of disciplinary sanction, a

manifestation of discriminatory approach in application and enforcement of the law.

- (vi) The totality of the 1st Respondent's acts amount to the 1st Respondent as a serving officer of the UPDF being:
- a) Partisan
 - b) Unprofessional
 - c) Indisciplined
 - d) Not of good character
- (vii) The action and inaction of the UPDF amount to discrimination and/or preferential treatment of the 1st Respondent as a child of the President.
- (viii) As a serving officer of the UPDF the 1st Respondent acted in an indisciplined manner lacking good character when with impunity breached the code of conduct for the Defence Forces.
- (ix) The UPDF and other security operatives were deployed to provide security and keep law and order for the 1st Respondent to celebrate his birthday. The deployment was an expenditure charged on the Consolidated Fund to benefit the 1st Respondent whose birthday celebrations were private and not a service of the Government. Additionally, the

withdrawal of funds to pay to the security operatives deployed to provide security and guard services to the 1st Respondent on his birthday were not authorised by law as an expenditure chargeable on the Consolidated Fund.

- (x) The actions, conduct and character of the 1st Respondent set a bad example to the nation in general and do jeopardize the rule of law, respect for the Constitution and the breeding of good, disciplined, law-abiding citizens envisaged under Objective 29 of the National Objectives and Directive Principles of State Policy, of the Constitution.
- (xi) The summation of the activities of the 1st Respondent, aggravated by the unqualified and unprecedented highhandedness, impunity and absolute disregard of the Constitution, together with the inaction or connivance of the 2nd and 3rd Respondents manifestly put the 1st Respondent at a position superior to the Constitution, which offends Article 2 of the said Constitution that provides for the supremacy of the Constitution.

7. That it is in great public interest that the 1st Respondent's actions, character and conduct be declared illegal and un-constitutional in order to redeem the sanctity of the Constitution of the Republic of Uganda and to also restore harmony and public confidence in the Uganda People's Defence Forces (UPDF) which is supposed to be a national army.

This Petition is supported by the affidavit attached hereto, deposed by GAWAYA TEGULLE, Esq and the said affidavit shall be relied on at the hearing of the petition, along with other affidavits and evidence that shall be made available before the hearing.

WHEREFORE your Petitioner brings this petition in the higher public interest, for the good of the Republic of Uganda and in defence of the Constitutional order and promotion of rule of law and good governance, and humbly prays that this Honourable Court may be pleased to grant the following declarations and orders;

1. Declarations that;

- a) The actions, activities, conduct and character of the 1st Respondent as highlighted hereinabove, while still serving as an army officer, contravene Articles 2, 3, 21, 208(2), 208(3), 209 and 210 of the Constitution of the Republic of Uganda.
- b) By violating the Constitution as contended herein, the 1st Respondent committed the offence of treason and is liable to prosecution in accordance with the law as laid down.

- c) The inaction, inertia and omissions of the 2nd Respondent in as far as he has failed, refused or otherwise omitted to supervise, oversee, restrain or otherwise call the 1st Respondent to order, to cease and desist from mounting a political campaign while still serving in the army, is/are unconstitutional.
- d) The failure or refusal by the 3rd Respondent to provide due legal advice to the Uganda Peoples Defence Forces in general and the 1st Respondent in particular, to cease and desist from mounting a political campaign while still serving in the army is unconstitutional.

2. Orders that;

- a) The 1st Respondent cease and desist from carrying on his political activities while he is still serving in the army and that an injunction doth issue to that effect.
- b) The 1st Respondent be prosecuted for treason.
- c) The 2nd and 3rd Respondents discharge their constitutional mandate without fear or favour, and with effectiveness and efficiency to the last drop.
- d) Any other reliefs that this Honourable court may deem fit.
- e) Each party meet their own costs.

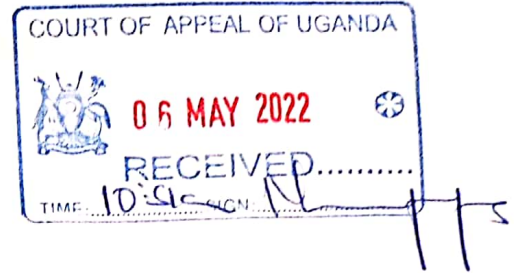

AFFIDAVIT IN SUPPORT OF THE PETITION

I, GAWAYA TEGULLE c/o of M/S Thomas & Michael Advocates, Plot 127 Muteesa II Road, Ntinda, P.O Box 73577 Kampala, Uganda and M/s Nalukoola Advocates & Solicitors, Ground Floor, Suite GS-7, Masengere Building-Mengo, Plot 1164, Bulange Way, and P.O. Box 27088, Kampala-Uganda do solemnly swear and state as here under;

- 1. That I am a male adult Ugandan of sound mind, a member of the Uganda Law Society, a practicing Advocate of Uganda’s Courts of Judicature, and also a Human Rights, Democracy, Constitutionalism and Good governance Activist. I am especially keen on constitutionalism and I firmly and solemnly consider it no less than my duty as a good citizen, to safeguard, ensure and

generally protect the sanctity of the Constitution of the Republic of Uganda; and I swear this affidavit in that capacity.

2. That as a responsible citizen of Uganda and a lawyer of good conscience and persuasion, I am aware of my duties as enshrined in the Constitution of Uganda including safeguarding the Constitution and promoting the rule of law and Democracy.
3. That Article 137 (3) (b) of the Constitution provides that "A person who alleges that any act or omission by any person or authority is inconsistent or in contravention of a provision of the Constitution may petition the Constitutional Court for a declaration to that effect or for redress where appropriate.
4. That Article 208 of the Constitution of the Republic of Uganda provides that "The Uganda People's Defence Forces (UPDF) shall be non-partisan, national in character, patriotic, professional, disciplined, productive and subordinate to the civilian authority as established under this Constitution" and Article 208 (3) provides that members of the Uganda People's Defence Forces (UPDF) shall be citizens of Uganda of good character.
5. That Article 209 provides for the functions of the Uganda People's Defence Forces (UPDF) which are (a) to preserve and defend the sovereignty and territorial integrity of Uganda (b) to co-operate with civilian authority in emergency situations and cases of natural disasters, (c) to engage in productive activities for

the development of Uganda while Article 210 provides that Parliament shall make laws to regulate the UPDF generally and in particular, the terms and conditions of service.

6. That it is upon this premise that this Petition is brought against the 1st Respondent - a serving, high-ranking UPDF officer whose actions, conduct and character contravene Articles 2, 3, 208(2) and 208(3), 209 and 210 of the Constitution of the Republic of Uganda.
7. That the 1st Respondent has held a series of well-publicised ostensibly "birthday parties", at which his presidential ambitions and intent have been trumpeted blatantly, unapologetically and unrepentantly, with manifest impunity of 'I-can-do-what-the-heck-I-want-regardless' proportions. He has attacked the Constitution of the Republic with a carving knife and woe betide me, if I keep silent and sleep in peace, as the Grundnorm is being sliced into small pieces and fed to the dogs!
8. That whereas the Constitution provides under Article 208 that members of the UPDF shall be **non-partisan**, professional, disciplined and of good character, the 1st Respondent has disregarded the Constitutional provision and gone ahead to directly and indirectly engage in partisan political activities among which are directly campaigning for Presidency of the Republic of Uganda through his known close friends, mercenaries, social media hooligans and bloggers, some cliques in the National Resistance Movement (NRM) Political Party youth wing, allowing the circulation of posters, fliers, T-shirts with his

face and words indicating that he intends to run for Presidency in the next (2026) Presidential election and he himself will not stop until Uganda is fully his. **(A copy of the 1st Respondent's tweets, posters and fliers are hereto attached and marked annexure "A" "A1", "A2", "A3", "A4" respectively).**

9. That there are several campaign posters with the 1st Respondent's picture that have been seen displayed all over the Country and the 1st Respondent a serving army officer of high rank who is even aware (and/or ought to be aware) of the consequences has never come out to speak against the use of his pictures in activities that contravene the Constitution and the UPDF Act. **(A copy of the pictures is hereto attached and marked annexure "B", "B1", "B2" "B3")**
10. That whereas I acknowledge that the 1st Respondent has a right to contest for any political office of his choice as a Citizen of this Country, he is constitutionally barred from doing so while still a serving army officer and any doubt about this is clearly removed by Section 99 of the UPDF Act, which was made under the Constitution.
11. That the 1st Respondent, in violation of Articles 2, 3, 154, 208, 209 and 210 has further manifestly and unconstitutionally taken advantage of the UPDF personnel, structures and resources - both financial and logistical - to unlawfully pursue his political ambition in complete disregard of the Constitution of the Republic of Uganda and the UPDF seems fearful and/or powerless to stop

him, or is in connivance with his unholy, unlawful, unpatriotic, unacceptable and unconstitutional actions and ambitions.

12. That if such actions, conduct and character of the 1st Respondent are not declared unconstitutional, they are likely to promote disrespect for the Constitution of the Republic and cause disharmony within the Uganda People's Defence Forces (UPDF) which under Article 208 of the Constitution is supposed to be non-partisan, national in character, patriotic, professional, disciplined, productive and subordinate to the civilian authority.
13. That the 2nd Respondent has not advised and/ or warned the 1st Respondent about the legality of his actions, character and conduct even when it can clearly be seen that they are in contravention of the Constitution of the Republic of Uganda (, in violation of Articles 2, 3, 208 209 and 210 of the Constitution), the Uganda People's Defence Forces (UPDF) Act, the and Presidential Elections Act, neither has he restrained him.
14. That the 3rd Respondent has omitted, failed or otherwise refused to provide good, fitting and proper legal advice and guidance to the UPDF in general and the 1st Respondent in particular that the acts and overtures of the 1st Respondent are manifestly unconstitutional and not tenable in an army which is supposed to be professional, non-partisan and of good character, in breach of Articles 2 and 119 of the Constitution.
15. That the 1st Respondent, who also happens to be the son of the current President of the Republic of Uganda, General Yoweri

Kaguta Tibuhaburwa Museveni, is enjoying unlawful and unconstitutional preferential treatment from the UPDF, and is not being duly reprimanded, supervised or otherwise called to order by the 2nd Respondent simply because he is the son of the President, which manifestly offends **Article 21** that provides for equality before and under the law.

16. That the summation of the activities of the 1st Respondent, aggravated by the unqualified and unprecedented highhandedness, impunity and absolute disregard of the Constitution, together with the inaction or connivance of the 2nd and 3rd Respondents manifestly put the 1st Respondent at a position superior to the Constitution, which offends Article 2 of the said Constitution that provides for the supremacy of the Constitution.

17. That Ugandans are witnessing a patent act of high treason, in full flow and in the full glare of cameras local and international, as a man, intent on capturing state power, using means and methods that offend the sacred Constitution, and in particular Article 3 (1) & (2) continues unchecked.

18. The actions, conduct and character of the 1st Respondent set a bad example to the nation in general and do jeopardize the rule of law, respect for the Constitution and the breeding of good, disciplined, law-abiding citizens envisaged under Objective 29 of the National Objectives and Directive Principles of State Policy, of the Constitution.

19. That aside from being unconstitutional and highhanded, the acts of the 1st Respondent are an unqualified assault on constitutionalism and an unacceptable insult to the intelligence of Ugandans of good conscience, who love their country and who entertain a healthy respect for rule of law, constitutionalism and good governance and whose hearts beat in tandem with the eternal words engraved in the Preamble to the Constitution, to wit:

- *"...RECALLING our history which has been characterised by political and constitutional instability;*
- *RECOGNISING our struggles against the forces of tyranny, oppression and exploitation;*
- *COMMITTED to building a better future by establishing a socio-economic and political order through a popular and durable national Constitution based on the principles of unity, peace, equality, democracy, freedom, social justice and progress;"*

20. That it is in the high public interest that the 1st Respondent's actions, character and conduct be declared illegal and unconstitutional in order to redeem the sanctity of the Constitution of the Republic of Uganda and to also restore harmony and public confidence in the Uganda People's Defence Forces (UPDF) which is supposed to be a national army but is being portrayed by the 1st Respondent as a personal outfit.

21. That this Honorable Court is endowed with due mandate to interpret all laws in the Country and to put acts and omissions of

all persons that hold power of any kind on the weighing scale to ensure that there is a harmonious co-existence and compliance with the provisions of the Constitution.

22. That this petition is brought in the higher public interest and that it is just, fair and fitting for the national interest, rule of law and constitutionalism that this petition be honoured and the prayers herein be granted.

23. That whatever is stated here in above is true and correct to the best of my knowledge.

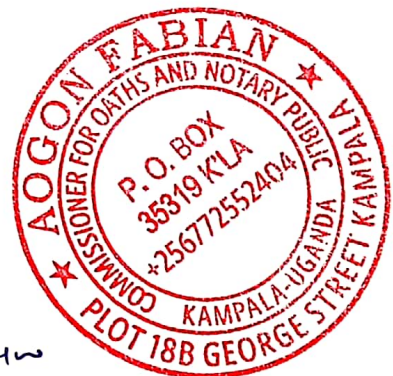
